## *Madeline's Cottage* and New Site Improvements to Maryhurst Campus

A vision several years in the making, Madeline's Cottage has finally become a reality. All of the planning, preparation and behind the scenes work (not to mention dollars raised) has become a permanent fixture on the Dorsey Lane campus in eastern Jefferson County as of June. The brand new 7,700 square foot residence, home to 14 girls, culminates our three-year *Stand Up for Girls* capital campaign, which was designed to re-envision Maryhurst's 38-year old campus raising nearly \$2.9 million dollars. The improved campus plan will better provide for the children's safety and therapeutic needs, as well as the organization's sustainability, while giving the girls a space that is more "home-like."

This new residence has been designed to provide the best possible treatment environment for our girls. With the new cottage we will also celebrate the opening of our new walking trail and Butterfly Garden. I am so grateful to all those who helped us strengthen our services, add wonderful new features to our campus, and focus on securing our future funding.

So now you see why I need another Thanksgiving on my calendar. Yes, there are days when I feel tired. Yes, there are obstacles that can seem overwhelming, but through it all, I am grateful – for this place, this job, this opportunity to make a difference in our world, and for you who have been a part of all of this each step of the way.

All of the capital improvements will be designed for maximum sustainability and function. The sustainability efforts will encompass a number of areas, including environmental stewardship, green technology, energy efficiency, maintenance and durability. Our ultimate goal is to create an environment that promotes healing and will complement our programming initiatives.

Furthermore, for the first time on campus, a new sensory therapy room (known as the Snoezelen Room) funded by the WHAS Crusade for Children has been designed with our children's specific needs in mind. The equipment will engage sight, hearing, touch and smell, as well as have neutral wall and floor surfaces to allow images to be projected on them. All cottages on campus will benefit from using the new space.

In addition, many new overall site improvements are now available to the residents at Maryhurst. The new walking trail, thanks to funding by the Humana Foundation, will cross a large part of the campus. We are excited to

partner with Bernheim Arboretum and Research Forest to add trees, native landscaping, new gardens and an orchard where girls can pick and eat food that they help grow.

The new Butterfly Garden, thanks to Foxhollow Farms, will provide an outdoor educational experience for the girls in our care. They will have the opportunity to plant and eat their own foods; experience aromatherapy classes, learn about soil, all while learning in a therapeutic atmosphere. Maryhurst is thankful to the Jefferson County Master Gardner Association for partnering with us to maintain this space.

We hope, if you have not already, that you will come out for a tour of Madeline's Cottage, as well as visit our new outdoor education spaces. ## Maryhurst closes out *Stand Up for Girls* Campaign

While there are still additional funds needed to meet the campaign goal, the funds have already begun making a difference in the lives of the children we serve from both a programming and capital standpoint.

Over the next year, the initiative to raise the remaining \$300,000 for our endowment will continue. By investing in Maryhurst's long-term operation, it ensures a gift of perpetuity and helps provide for the future of the organization. Many thanks to the nearly 300 individual donors, corporations and foundations that helped bring the campaign to fruition. We are grateful for their generosity and are excited that everyone who donated to the campaign will have a permanent fixture in our new cottage thanks to the commissioned donor wall by Tracy Pennington from Madcap Mosaics.

In order to sustain the tradition of hope and healing that has defined Maryhurst for 170 years, we rely upon the generosity of our friends for financial support of our programs. Annual gifts are a critical component of our budget each year, while planned gifts help us both with our operational budget and our endowment.

By sharing a planned gift with Maryhurst and becoming a member of the *Legacy of Hope Society*, you will ensure that our caring, expert programming will be around to serve many thousands of children in the future just as it has since our beginning.

Planned gifts provide you with a variety of benefits which may include life income, continued use of gift property, an avoidance of capital gains tax, and immediate tax deduction.

**There are several ways to make a planned gift to Maryhurst:**

## Bequest

A bequest is a gift made through a provision in your will naming Maryhurst as beneficiary. A gift of this type may reduce estate taxes. By notifying the Development Office of your gift, we will name you and/or your family as a member of the Legacy of Hope Society. There are three common options to consider when making a bequest to Maryhurst.

### Specific Bequest

I, John Q. Public, do hereby devise and bequeath to Maryhurst, Inc., a Kentucky not-for-profit organization, located in Louisville, Kentucky,

the sum of \$100,000 to be used (a) for the benefit of Maryhurst as the Board of Directors may determine; or (b) for a specific purpose, the criteria for which is on file at Maryhurst.

### Percentage Bequest

I, John Q. Public, do hereby devise and bequeath to Maryhurst, Inc., a Kentucky not-for-profit organization, located in Louisville, Kentucky, 50% of my estate to be used (a) for the benefit of Maryhurst as the Board of Directors may determine; or (b) for a specific purpose, the criteria for which is on file at Maryhurst.

### Residual Bequest

(a) All the rest; or (b) x% of the rest, residue and remainder of my estate, both real and personal property, I give, devise and bequeath to Maryhurst, Inc., a Kentucky not-for-profit organization, located in Louisville, Kentucky, to be used (a) for the benefit of Maryhurst as the Board of Directors may determine; or (b) for a specific purpose, the criteria for which is on file at Maryhurst.

## Life Income Gifts

Life income gifts provide you with a regular income stream while also providing financial support to Maryhurst. Common gifts of this type include charitable gift annuities and charitable remainder trusts.

## Beneficiary Designations

A beneficiary designation allows you to continue supporting our work even after your lifetime by naming Maryhurst as beneficiary of your retirement plan, life insurance or insurance annuity assets.

### Maryhurst Partners with Business and Professional Women


