# FROM OUR PRESIDENT/CEO



This year was Paula's first as CEO after predecessor Judy Lambeth retired in June 2020 after 45 years.

She immediately stepped into the role of leading the agency through the COVID-19 pandemic.

It wasn't how she envisioned beginning her role as Maryhurst CEO, but she's had the opportunity to draw such leadership inspiration every day from special people around our agency.

2020 was a year like no other in the 177-year history of this agency.

As Maryhurst navigated the ongoing crises that impacted on our community – COVID-19, social unrest, and all the consequences of isolation – our staff and those we serve were profoundly affected.

We directed every resource and effort we could to ensuring our community's continued emotional, physical, and mental health. Throughout it all, I saw such incredible acts of kindness and service – acts that have built in me a deep confidence that we will emerge from the pandemic a better, stronger Louisville. And a stronger Maryhurst.

Some 2020 highlights include our first-ever Week of Hope, a new digital fundraiser that we held in lieu of our typical luncheon gathering; our donor community rallied during Week of Hope and in so many other ways, making sure Maryhurst never exhausted our supply of sanitizer, PPE, or meals to keep staff fed.

In addition to Week of Hope, our Renewal program was able to adapt quickly to telehealth, meeting with clients safely and providing muchneeded wellbeing resources for families who may have had difficulties like job loss or illness. Renewal teams also organized food relief and did grocery drop-offs for neighbors in the community.

Finally: generosity from supporters like those listed in the pages that follow allowed us to prepare to launch a brand-new Maryhurst service, a dedicated Aftercare program, which will make sure youth exiting our programs remain in touch and have the skills needed to navigate and flourish in early adulthood.

All in all, partners like you help us to transform the lives of nearly 700 children and families each year. Thank you!

# **PANDEMIC** MILESTONES

### **Responding Quickly**

When the pandemic reached KY in March, we collaborated closely with local health officials to make sure we were observing all recommended guidance (physical distancing, hand washing, etc.).

## Mar-Apr

- Created a special COVID-19 taskforce led by our on-staff nurse manager and operations chief.
- Began performing daily temperature checks and routine health screenings.

# 3-YEAR PLAN

### **Defining our vision and impact...**



In 2020, Maryhurst debuted our Strategic Plan, a document that describes how we want to fulfill our mission over the next several years. The plan is composed of five separate but interrelated priority 'initiatives,' each of which are listed below.

Ultimately, the plan lays out our goals & the steps needed to achieve them. It was created by considering internal staff feedback via listening sessions, as well as by evaluating external sources (e.g. upcoming legislation that could impact our operations).

## 1. Trauma Informed Care Prioritizing Our Resilience

Activities rooted in evaluating our current trauma informed care treatment approach, making sure we remain a leader in evidence-based practices and resilient community-focused work.

## 3. YOUTH PERMANENCY Securing Our Kids' Future

A series of initiatives meant to increase Maryhurst's ability to ensure successful transitions for children with complex needs who have been successful in residential treatment settings to loving, nurturing homes or independent living programs.

## 2. COMMUNITY SERVICES Ensuring Our Families' Wellbeing

A plan to grow Maryhurst's services and identity related to intensive outpatient services, especially leveraging them as an alternative to residential placements and hospitalizations.

## 4. STAFF DEVELOPMENT


Valuing Our Teams' Work
